NOTICE is hereby given Hope Gas, Inc., dba Dominion Energy West Virginia (the "Company"), a public utility, has filed with the PUBLIC SERVICE COMMISSION OF WEST VIRGINIA, a tariff containing increased rates, tolls and charges for furnishing natural gas service to all of its customers at various locations in the Counties of Barbour.
